# **AUTHORIZATION REVIEW PROCESS – SIMPLIFIED!**

# Step I – Define Scope of Process ➤

- Choose what to review:
  - o Possible Activities all activities, sensitive activities, activity groups, activity modes such as *display, change, execute*.
  - o Activities (Real Use) actually used activities, unused activities (before removal).
  - o Authorization Roles all authorization roles, sensitive roles, composite roles, active business process roles.
  - o Specific Permissions read/write access to organizational objects such as company codes.
- Choose whom to review:
  - o All employees/specific employees, all systems/specific systems, employees with certain criteria, employees with certain jobs.

# Step II - Commence Review >

A list of authorizations is emailed automatically to first level of approvers; managers see their employees and related authorizations only. Authorizations can be approved or rejected by the manager. If rejected an explanation must be provided, facilitating the next level of approvers.

#### Step III - Complete Review >

Upon reaching well-grounded decision, the next level of approvers is able to confirm all authorizations that were already approved in just one click.

#### Step IV - Seal Process >

Upon completing the process, the authorization request is sent to security managers who can implement changes or forward requests to helpdesk for final handling.


